- An OSU calorimeter and associated accessories complying with *FAR/CS 25 app F part IV; AITM 2.0006 (2009, Chapter 5 of the Aircraft Materials Fire Test Handbook.*

◆ Main features:

- OSU
 - The test equipment, complying with the previously mentioned standards.
 - A calibration rig with centre and corner transducers
 - A calibration burner
 - A spark ignitor (or equivalent method) should be installed to ensure that the lower pilot burner remains burning.
 - A mass flow controller or a mass flow meter for the calibration of the methane gas
 - A software allowing to automatically run calibration and calculate test results
 - 2 specimen holders (+ drip pans) as described in paragraph 5.3.6 of the aircraft materials fire test handbook.
 - A wet test meter
 - Installation of the device

- The test equipment : the new FAA NexGen Burner consisting of: Cone, Fuel Nozzle, Stator, Draft Tube, Muffler, Pressure Regulator, Turbulator, Igniters, Housing, Cradle, Sonic Choke and Pressure Transducer.
- The NexGen burner support and positioning assembly.
- A control unit with burner control instrumentation allowing to remotely control flame application period, to monitor the warm up period, to record flame subsequent to flaming application, to remotely control the position of the burner from idle (setting of the flame) to the test position.
- A thermocouple rake assembly.
- A flux transducer calibration assembly.
- A data acquisition system allowing to record all outputs from heat flux transducer and thermocouples.
- All the specimen support system needed to perform the previously mentioned test.
- A 23 litres fuel delivery unit.
- Installation of the device.
- Acquisition data and data treatment results program with free updates lifelong.

Concerning this device a support of the supplier concerning the following points will be a plus:

- the global insulation of the test room (walls, top)
- the conditioning of the fuel tank (at a temperature lower than 10°C)
- the protective clothes recommended
